

# ENTERTAINMENT CONTRACT

EMPLOYER will provide a performance area, preferably an elevated stage, which is substantially firm, level, uniform and measures no less than twenty-four by sixteen feet. An acceptable substitute is sixteen feet by twelve feet. The performance area will be sufficiently protected from the elements, in order that musical instruments, electronic gear and related equipment will not be exposed to moisture, extreme heat or airborne contaminants.

EMPLOYER understands that the following AC power requirements apply to the performance: four (4) twenty-amp 110-volt circuits. An acceptable substitute is two (2) twenty-amp 110-volt circuits and a single fifty-amp 220-volt circuit. All required power will be made available at the rear of the performance area.

If EMPLOYER defaults on the terms of this Contract, EMPLOYER shall pay interest on any unpaid sums at the annual rate of EIGHTEEN PERCENT (18%). Should PERFORMER be required to pursue legal remedies to enforce these terms, EMPLOYER shall be liable for attorney fees and costs incurred by PERFORMER.

EMPLOYER understands that, should a performance be canceled or terminated prematurely for reasons outside the control of PERFORMER, EMPLOYER is obligated to tender payment hereunder if PERFORMER appears at the place of performance, ready, willing and able to perform.

Either party may cancel the engagement \_\_\_\_\_ or more days prior to the performance without recourse to the other. However, should either party cancel the engagement within less than thirty days' notice, then the defaulting party shall be liable to the other for one-half of the above-agreed compensation as liquidated damages. If the performance is rendered legally impossible by any cause, it may be canceled by either party without recourse to the other.
